- 2. Election of Vice Chair
  - Cllr Richard Lewis proposed Cllr Andrew Beavan for Vice Chair. Seconded by Cllr Roger Thomas. Agreed unanimously.

- 4. Chair's report
  - This was adopted by the council and will be presented at the Annual Parish Meeting on 24<sup>th</sup> May.

- 7. Minutes of previous meetings
  - Draft minutes of the Llanfairwaterdine Parish council meetings held on March 10<sup>th</sup> and April 21<sup>st</sup> were agreed and signed as a true record.

- 10. Community Led Plan
  - As this is now a finished document, it will be used as a working document for the Council to update the Development Plan.
  - Council resolved to formally ask the different interest groups within the parish to consider results for the CLP with a view to a public meeting later in the year. Cllrs Hughes and Thomas agreed to take this forward.
- 11. Review of Councillor conduct and internal inquiries
  - The Chairman proposed a resolution to exclude public and press from the
    discussion of this matter as this review would include employment matters, and
    therefore should be discussed at the end of the meeting. Seconded by Cllr Roger
    Thomas. Agreed. After this matter was subsequently discussed a Council
    Statement was produced and a copy can be viewed on council notice boards and
    website.
- 12. Shropshire Councillor's report Cllr Nigel Hartin
  - Cllr Hartin outlined changes to the County Council leadership and decision-making processes designed to be more transparent. He outlined budget cuts amounting to over £140m (or 40%) compared to five years ago. This results in, amongst other things, 50% fewer staff than four years ago and a £30m shortfall on last year's budget.
  - SCC will be forced to withdraw many non-statutory services and will be asking local communities so help find ways of maintaining these.
  - Cllr Hartin also spoke about changes to the Affordable Housing Levy whereby developments of fewer than 10 houses no longer have to pay the levy which will reduce the amount available for affordable housing in the county.
  - The Fire Service will now fall under the control of the Police Commissioner.

Some pot holing and drain unblocking work has been carried out since our last report, and we now look forward to the major work due to take place from Teme Cottage Bridge, through the village This will involve cutting into existing drives etc., sorting out drains and overlaying with Tarmac. It is likely to be done in three phases during which time there will be some disruption to traffic. However the resulting improvements should be considerable.		

No date has been set for this work, but it is unlikely to be carried out before the autumn .The Council will be looking to keep everyone informed when information becomes available.

Council has not received any other highway issues of urgency. However we are aware from the Community Led Plan that 51 people said they were willing to monitor and survey road condition and usage within the Parish.

The Council will be considering how best to coordinate this very positive offer from parishioners in the near future.

Since our last report the board of Trustees has been brought up to full strength, thanks to the nomination by the Parish Council on 19th January of Graham Trew and Roger Thomas to serve four year terms as Trustees. We are very grateful for the considerable time, thought and care that you gave to the task.

At the three Trustee meetings since then we have conducted a full field visit and then successfully let the grazing of the Trust's land;

we have considered applications and duly awarded four educational bursaries and one general benefit grant - to the Llanfair Singers; we have identified one more household where the peace of mind of both the occupants and their wider families can be assisted through the installation of a fully funded Panic alarm - these are monitored 24 hours a day by Herefordshire Housing; we have also decided to organise another informal summer event, this year at The Triangle, for Saturday 2nd July, in conjunction with Life, Land & Livelihood, the Offa's Dyke Association and various other organisations and individuals; this will involve guided walks and talks, plus a barbecue and applebased liquid refreshments. Everyone welcome, so please pass the word!

#### Report:

l attended the Public LJC meeting held in the SpArC centre Bishops Castle on April 14<sup>th</sup>. Most Council representatives and our county Councillors were present to hear the important presentation on the future of Shropshire Council Services in South West Shropshire. The Hall was full of members of the public who appeared to have gathered out of concern as to the future of SpArC itself.

Malcom Pate leader of Shropshire Council lead the presentation supported by the Chief Executive of Shropshire Council Clive Wright.

Malcome Pate stated that there was a huge challenge in Shropshire to continue to deliver services in the future due to budget cuts. He said that the Government formula was wrong and was working against Councils such as Shropshire with a large number of older residents. He said he had a meeting planned with Greg Clark in May and that this was the best hope of Shropshire getting a better deal from Westminster.


It appears likely that Shropshire Council will seek to work in partnership with town and Parish Councils to deliver services such as libraries ,road maintenance etc at a local level ,there may be precept implications to some to these initiatives.

Clive Wright went on to say how efficient Shropshire Council had become with statutory duties but that Government cuts meant that funding of £200 Million would effectively become £20 Million.

Nearly all questioning came from the Public and was in relation to the possible closure of SpArC .Feelings were running high with considerable local support to keep the centre open . Clive Wright urged local groups and Councils to come up with a management plan and to speak to Shropshire Council who would be keen to support and facilitate a solution to keep the centre open.

Other business was that the youth budget of £3000 had all been allocated and a further £3000 would be available for 2016/17, however this is likely to be the last year it will be available.

Two Local Grant applications were considered and approved those being The Bent Lawnt Memorial Project and the Hazelhurst CloseTenants Association for the establishment of a Lunch club.

#### Report:

I attended this one-day course in Leominster Priory on 7 May, which was hosted by the Dean of Hereford Cathedral and Mike Keel, the Chief Executive of St Michael's Hospice, also in Hereford. This was a fascinating day: course participants came from a wide range of backgrounds, the course being held for those wishing to find out more about the process of bereavement and those, like us, with community responsibilities.

Firstly, a word about helping the bereaved. We were told that a manual for those in the mental health professions has, in its latest publication, included grief as an illness. It is clearly not an illness but a process through which people go. There is no cure for bereavement, as it is not possible to give back to the person what they have lost. Rather, there are behaviours of others — neighbours, friends — that certainly help.

Professor Allan Kellehear thought that there was too much emphasis – even an obsession – with professional interventions. The bereaved are often alone because there is still a notion that bereavement is best dealt with by professionals. Professor Kellehear dispelled this myth. Certainly professionals will hopefully be good listeners, but they might be under undue pressure, which community members might not. We need to look to each other within the community. Loss is universal and we will all experience it at some time in our lives – so why make it a trained person's responsibility?

We heard from Christina Welch of Winchester University about the role of supporting the bereaved from many different faith communities and there was a marked difference in the way in which this takes place in the Christian tradition and, for example, within Judaism.

Helen Clarke reminded us that bereavement recovery is not linear. I think we might all have asked the bereaved how they are. The answer often confirms Helen Clarke's statement, as they say something like "I have my good days and I have my bad days". Helen noted that on the one hand there will be loss-orientation, denial and the avoidance of change. On the other hand there will be restoration-orientation, doing new things, attending to changes, denial and avoidance of grief. Typically, the bereaved will move between the two states.

It was stressed that if we are with the bereaved it helps to: listen:

to respond appropriately; to get resources and advice and

to look after yourself.

Do not say to the bereaved that you know how they feel – you don't but do say that you would like to do something to help and ask for a job. Be prepared to be with them there for the long haul.

I have the following resources: "Has Someone Died?" and a "Bereavement Support Directory". I will be ordering "Is there anything I can do? How to help someone who is bereaved" and "Facing Bereavement", which I am happy to share or to be a Parish Council resource.

Lastly, we were told that we need to look after one another and be part of creating caring communities.

Report: I attended a course in the Bishop's Palace in Hereford about Diocesan (and County) support for refugees. Bishop Richard, the Diocesan Bishop, spoke and facilitated other speakers, most notably Martin Samuels for Herefordshire Council and Jeffery Beatty who told us of experiences in Wales, mentioning Brecon, Hay and Talgarth Group, and the City of Sanctuary movement. There was a wide range of course participants, from, for example, Homestart, the Samaritans and the local Christian denominations and the Muslim community, to those representing the Diocese in different ways and those who were simply representing themselves and their families or parish groups. It is seen as important to cascade the information from the evening to Parochial Church Councils and to Parish Councils. Our county, Shropshire, was apparently in the forefront of developments by appointing a full-time refugee officer.

Martin Samuels clarified the situation for us thus, speaking at length:

There are three groups of people, all of whom are very vulnerable.

The three groups are:

Unaccompanied children: 1000 have been placed and there are already more to arrive. Herefordshire, for example, at the moment, has six children and is taking six more who will go into foster care.

Asylum seekers: these are mainly young adult men. They are not allowed to work. Their assessment is outsourced. They are not encouraged to integrate.

Syrian refugees: They are from the camps along the Syrian border and are family groups with five years' leave to remain. The Public Sector has a full range of statutory duties and the refugees have rights like ours.

How are Syrian refugees funded for education, health and general support? Year 1 funding comes from the Department of International Development;

Years 2 – 5 funding is by the Home Office.

Additional funds are available for those with complex needs.

Herefordshire will take 15 to 20 families (60 individuals) and this will be phased. People will go into up to three locations in Herefordshire and two in Powys. (Martin Samuels thought that circumstances were similar in other counties, so this also applies to Shropshire.) People will arrive in September after support services are sorted.

Will refugees go to the top of the social housing list? They will not. They will go into privately rented accommodation.

Syrian refugees are often able to speak English, having learnt it at school.

The City of Sanctuary movement offers respite for refugees. It seems unlikely that refugees will come here to settle as it is preferable for them to be in groups to avoid feelings of isolation in already traumatised people. However, some might benefit from respite days, as not all will have come from cities in their homeland: some will have come from a very rural setting. Knighton and District Refugee Support Group, of which a parishioner has recently been Chair, - they have a revolving Chair – looks forward to welcoming refugees, from a city, in June for a respite weekend.

We spoke briefly of the need for individuals and families to be able to worship: some refugees will be Christian but for those who are Muslim there are no Mosques hereabouts so temporary prayer space, even if small, will be an essential and courteous consideration and provision.
