## Llanfair Waterdine Parish Council

Minutes of the Scheduled Parish Council Meeting on Monday 15 January 2024 7.30pm at the Pavilion.

Present: Cllrs Andrew Beavan (Chairman), Mark Hughes, John Lane and Roy Lloyd. 2 vacancies.

- 23/67. Welcome. The Chairman welcomed everyone to the meeting.
- 23/68. **Apologies for absence** were received from Cllr Darren Knipe. Shropshire Councillor Nigel Hartin was not present.
- 23/69. Declarations of Interest and requests for dispensations. None received.
- 23/70. To consider applications for co-option to the Parish Council. No applications received.

## 23/71. Open Discussion

23/71.1 Views of the public parish matters. No members of public were present. 23/71.2 Report from Shropshire Councillor Nigel Hartin. No report received.

- 23/72. **Minutes**. Minutes of the scheduled Parish Council Meeting held on 20 November 2023 were agreed as a true record and signed by the Chairman.

- 23/76. Report from Cllrs Bevan and Lane following the Clerk's appraisal on 11 January. Noted: The clerk will be leaving at the end of March 2024. **RESOLVED** to advertise for a new clerk with Shropshire Association of Local Councils, on the Parish Council's website and, (as suggested by the clerk), on the *Community Clerks' Network* Facebook page. Start date 1 April 2024. Applications by end February, interviews will be held before 18 March 2024.
- 23/77. Budget 2024/25. RESOLVED to budget £7,106.22 for 2024/25. (See Appendix 2).
- 23/78. Precept. RESOLVED to set a Precept for 2024/25 of £5,500.00. Clerk to return form to Shropshire Council.

- 23/79. **Insurance**. Three quotations for Insurance from 16 Feb 2024 were discussed. **RESOLVED** to renew contract with Zurich insurance at a cost of £214.00. Clerk to arrange payment.
- 23/80. **Policies**. Agreed in principle to adopt the following: a) Complaints Policy; b) Complaints Procedure; c) Vexatious Complaints Policy. Clerk to complete drafts prior to the meeting in March.
- 23/81. Llanfair Waterdine Energy Project. An update was received from Cllrs Beavan and Lane following a meeting with Nick Read and Fiona Morgan, South Shropshire Climate Action, (SSCA) on 11 January.

**Background**: SSCA has been given a grant by Shropshire Council to undertake research over a period of twelve months to explore how communities in Shropshire can achieve Net Zero by 2030. Llanfair Waterdine Parish has been invited to participate in this Action Research Project.

Whether to sign up to this project was considered. **RESOLVED** before agreeing to sign up, a brainstorming meeting with key Parish groups and SSCA will be arranged in February.

23/82. **RESOLVED** to ratify decision to support Newcastle Parish Council in its endeavour to purchase the Crown Inn for the benefit of the community.

## 23/83. Highways / Public Rights of Way (PROW)

23/83.1 Issues relating to Highways.

- a) Subsidence/eroded bank with 4 to 4ft drop, 10yds below Duffryn Cottage near the parish boundary on the A4368 two miles west of Newcastle. Clerk to report to Shropshire Council.
- b) Road signs in need of cleaning. Agreed: to *not* report to Shropshire Council. Signs could be cleaned by working party.
- 23/83.2 Works under the Environmental Maintenance Grant. Completed: Drainage works from The Green to Llanfair Hall and Monaughty, and from Llanfair Hall up to Crwn Turn. Proposed: scrape debris from centre of road above Blaen-Y-Dre to Llantroft, drainage works in similar area. Cllr Beavan agreed to discuss with contractor.

23/83.3 Issues to report to the Footpaths Warden. Damaged step on PROW from Blaen-Y-Dre to Goodwin Cottage.

- 23/84. Availability of broadband in the Parish. No update received and no actions were considered.
- 23/85. Correspondence. To discuss in detail items of correspondence.
  - 23/85.1 The Police and Crime Commissioner's Safer Roads Fund. <u>https://www.westmercia-pcc.gov.uk/saferroadsfund/.</u> Agreed to not apply for funding as no specific projects could be thought of, and no concerns had been raised by the public.
